IMPOSTOR/WARNING

Julieanne J. Hueske

In the April issue of the RN Update we notified our readers that Julieanne J. Hueske worked as a registered nurse without a license to practice professional nursing in the State of Texas. Ms. Hueske was employed with a home health agency in Brenham, Texas from September 1998 through December 16, 1999. Ms. Hueske was indicted of a Second Degree Felony offense of "Tampering with a Government Record" which resulted from her forging of an RN license which she used to secure employment as a registered nurse. On April 27, 2000, Ms. Hueske was issued a deferred adjudication with eight (8) years deferred probation, \$2000.00 Fine, Court Cost and 500 hours of community service. The case was handled by the Washington County District Attorney's Office, we thank them for their work in prosecuting the case.

JOY LYNN HEBERT

aka: Joy Lynn Wood

Joy Lynn Hebert secured employment as a registered nurse with a nursing care facility in Kennedale, Texas. Ms. Hebert worked as a registered nurse at this facility from August 18, 1999 to September 29, 1999 and from January 24, 2000 to February 17, 2000. The facility contacted the Board office to verify licensure at which time they were notified that Ms. Hebert was not licensed to practice professional nursing in Texas and that the license number that she provided did not belong to her. Ms. Hebert was terminated from employment. In addition to her employment with the nursing facility the investigation revealed that Ms. Hebert has also worked for other healthcare facilities and home health agencies in the Dallas area. The Board is pursuing legal action against Ms. Hebert and the case has been referred to the Kennedale Police Department.

GWENDOLYN D. MCEVER

Gwendolyn D. McEver is not licensed to practice professional nursing in the State of Texas. She is a licensed LVN and her LVN license is in current status. Gwendolyn D. McEver secured a position as a nurse/assistant with a physician's office who specialized in plastic and reconstructive surgery in May 1994. Her duties included assisting the physician with surgical procedures, taking patient history and physicals and patient education regarding pre operative and post operative care. Ms. McEver used the initials R.N. after all of her entries in the patients' medical records. Ms. McEver remained in this position until May 28, 1998. Ms. McEver secured a position as a registered nurse with a clinic that specialized in hair transplants in Houston, Texas. Ms. McEver presented an altered RN's license and began employment in November 1996. Ms. McEver assisted in surgical procedures, administered anesthetics and patient education regarding pre-operative and post-operative care. Ms. McEver used the initials R.N. after all of her entries in the patients' medical records. Ms. McEver was terminated in January 2000 when a routine verification of her license revealed that Ms. McEver did not have a license to practice professional nursing.

The Board is pursuing legal action by referring this case to the Harris County District Attorney's office for appropriate action.

IMPOSTOR/WARNING

SHERI WOOD

Sheri Wood secured employment in a microdermabrasion company in Fort Worth, Texas. She represented herself as a registered nurse and has business cards printed with RN after her name. Ms. Wood worked at the company from November 10, 1999, through March 11, 2000. The owner of the company terminated her employment and referred the case to the Board Office after he was unable to verify her licensure using the social security number. The Board is pursuing legal action against Ms. Wood and the case has been referred to the Tarrant County, District Attorney's Office. The Board records reflect that there is another Sheri Wood legitimately licensed to practice professional nursing in Texas. This legitimate Sheri Wood resides in the Amarillo area and is employed there currently.

ROSA NAVARRO

Rosa Navarro held himself out as a Registered Nurse while interviewing for an RN position with a group of asthma and allergy physicians in Houston, Texas, on February 28, 2000. Ms. Navarro was not hired for this position, however her resume reflects that she had previously worked as a Registered Nurse in a physician's office. The physician has since expired, therefore the staff was unable to secure copies of the personnel file. The supervisor contacted the Board office to verify licensure at which time they were notified that Ms. Navarro was not licensed to practice professional nursing in Texas. The facility did not hire Ms. Navarro and they referred the case to the Board office.

ANGELA HARRIS

Angela Harris was employed as Admission/Marketing Director with a care center in Houston, Texas, she represented herself as an RN during the interview process. Ms. Harris worked at the facility from June 26, 2000, through August 15, 2000, during which time she continued to represent herself as an RN. Ms. Harris wore a name tag with RN after her name and represented herself as an RN to patients and the public. The facility contacted the Board office and was unable to verify licensure for Ms. Harris. Ms. Harris was terminated after she was unable to prove licensure and degree she listed on the employment application. The Board is pursuing legal action by referring this case to the Houston Police Department for appropriate action.

AHMAD TAUQUEER: Ahmad Tauqueer was employed as a registered nurse and signed RN after his name while employed with a Home Health Agency in Houston, Texas, during July 1999 and August 1999. The agency hired consultants to audit personnel records. The consultants contacted the Board and they were unable to verify Mr. Tauqueer's licensure. Mr. Tauqueer was no longer employed with the agency at the time of the audit and he refused to submit verification of licensure. The Board is pursuing legal action against Ms. Tauqueer. The case has been referred to the Houston Police Department, Major Offender's Division.
