Scope of Work – Renewal No. 3
Between
The Texas Board of Nursing
And
eStrategy Solutions, Inc.

This renewal agreement (the “Renewal Agreement”) is entered into by and between the Texas Board of Nursing (the “Board”) and eStrategy Solutions, Inc. (the “Contractor”) (collectively referred to as the “Parties” or individually as a “Party”) in order to renew the attached Scope of Work, which was submitted under the terms and conditions of the Texas Department of Information Resources (“DIR”) Contract DIR-SDD-1937. The Scope of Work was effective on September 30, 2016; renewed on August 23, 2017; amended on May 4, 2018; and renewed on August 7, 2018 (collectively referred to as the “Scope of Work” and attached hereto as “Exhibit A”).

This Renewal Agreement to the Scope of Work is submitted under the terms and conditions of the Texas Department of Information Resources (“DIR”) Contract DIR-SDD-1937.

The Period of Performance of the Scope of Work is renewed by mutual agreement of the Parties, and shall be effective from September 1, 2019, to August 31, 2020. Pursuant to the terms and conditions of the Scope of Work, this renewal is the Parties’ last and final option to renew the Scope of Work.

The Parties agree that all of the terms and conditions of the Scope of Work, not amended by this Renewal Agreement, shall remain in full force and effect as originally negotiated and written. In the event of conflict in any language in the Scope of Work and this Renewal Agreement, the language in this Renewal Agreement will control. Should it at any subsequent time appear that the modifications specified herein conflict with any relevant provision of State law, the Board reserves the right to alter this Renewal Agreement to ensure its conformity with State law.


The Scope of Work, together with this Renewal Agreement and DIR-SDD-1937, contain the entire agreement of the Parties hereto with respect to the subject matter hereof. Any representations, inducements, or agreements, oral or otherwise, between the Parties not contained in this Renewal Agreement shall not have any force or effect. This Renewal Agreement may not be modified, changed or terminated, in whole or in part, in any manner other than by an agreement in writing signed by duly authorized representatives of the Parties.
